My Favorite Partner

In 1991 I married my husband who played bridge. He traveled all thru the U.S. and Canada to tournaments that lasted 10 days. I felt the only way I would see him was to take up the game, so I called my mother and asked her to take lessons and I would also take lessons and we would go to the tournaments and play bridge. She lived in Chicago and I lived in California so we agreed to meet at the tournament. We went down to play the first day in the 0-5, and, when we won, we were given a trophy. I came to my room so proud and disappointed my husband won nothing, Oh well, tomorrow is another day.

The next day we won two trophies, but none for him. He did mention he was in the finals of the Life Master Pairs. What are the finals compared with a trophy? My mother returned home with six trophies and my father placed them on a shelf and bragged to everyone how great she was at bridge.

That was the beginning of a wonderful 15 year journey playing bridge together. My mother was a fierce competitor and always played well until she would take a break and drink her coffee and eat her cookie. Then she barely looked at the cards as she was savoring every morsel and drinking down her warm delicious coffee after every bite. Often she would not follow suit and we would go from a good game to a bad one. After many games displaying this behavior she was no longer allowed to have coffee and her cookie while playing bridge with me. She understood why, but pouted every time she gave up her treats. We discussed the hands and got frustrated over our mistakes and laughed so often. We just had fun.

These were the greatest times we spent together. We were mother and daughter and bridge partners – which only adds to the void I feel when I sit down to play bridge knowing she will never be sitting across from me again. But also grateful for all the memories I have of the times we were together.
